Minutes: Motion made by Patty and seconded by Alice to approve the January 25 Organizational meeting minutes as presented. **Motion passed unanimously.**

Presidents Report: Jan reported that there is a new homeless tent in the preserve. The Homeless outreach team with the Sheriff Department has been contacted to issue trespass warnings and have the homeless removed.

Committee Reports

Landscaping Committee – Dick reported he has a second proposal from Twin Palms for the palm trimming. Dick recommends having Twin Palms do the palm tree trimming at @ \$1,625. Brian recommended having the palms trimmed in Late May prior to Hurricane season. Dick stated that there will need to be a walk through to diagnose the sod condition. The Irrigation mapping was discussed for VCA. Southy County will also be giving a proposal to Villa Paradiso for the irrigation maintenance. Twin Palms has agreed to remove the irrigation from the contract. Discussion followed regarding the landscape replacement around the AC units which is a voluntary option. This would not affect the view from the street. The next phase that would be done will be started in 2024.

Discussion followed regarding certain violations in the neighborhood including bird feeders and unapproved plantings. **Architectural Review Committee** – Dick mentioned he heard that an owner wanted to install a 16ft extension of their lanai. The Board agreed that this cannot be done and would be denied due to the size.
