Minutes: Motion made by Darrell and seconded by Eileen to approve the January 20th 2022 Board meeting minutes with corrections. **Motion passed unanimously.**

Presidents Report: Jim Reported:

- a. Vote to appointment new Board Member: Jim Announced that Betty Rich has submitted her letter of resignation form the Board of Directors. Jim thanked Betty for her service to the Board.
 - A **MOTION** was made by Eileen and seconded by Darrell to accept the resignation letter from Betty Rich. **Motion** passed unanimously
 - A **MOTION** was made by Darrell and seconded by Eileen to appoint Madeline Salerno to the Villa Vivaci Board of Directors. **Motion passed unanimously**
 - A **MOTION** was made by Eileen and seconded by Darrell to appoint Madeline Salerno as Secretary to the Villa Vivaci Board of Directors. **Motion passed unanimously**
 - Jim reported that the No Trespassing signs have been placed on Jacaranda Blvd. Juniper has officially started and is making a difference in the landscaping. The irrigation at zone one has bee giving issues and is now working. Juniper will complete a total inspection of the irrigation components. The landscaping at the FPL transformer at the end of Cancello Grande dr.

Treasurers Report: As attached to these corporate documents Brian Rivenbark read from the January 2022 financials. Brian stated that the financials are now on the website for Villa Vivaci.

Committee Reports

- **a.** Landscaping Committee Chuck Dewire reported that the landscape committee met to review the irrigation system.
 - **A MOTION** was made by Darrell and seconded by Eileen to approve the \$160 to replace 4 irrigation filters to be expensed out of budget line item 7150 Irrigation repairs and Maintenance. **Motion passed unanimously**
 - Zone 1 had a plug that was pulled out form the controller. The lock was also broken. Zone 4 has an issue with algae in the filter. The breakers for this zone were turned off and this is not caused by themselves but could have been caused by the clogged filters. There is a need for a vertical preserve cut along the back of Cancello

Grande. The fallen tree behind Bella Pasque will be removed tomorrow. The mulch has been installed. The grass triangles should be paved over. The Green transformer at the end of Cancello Grande will need to be graded. Steve Johnson stated that FPL stated that some planting can be placed around the box but if they do need to get into the box, they will need to remove the plantings. Chuck discussed the enhancement planting plan from villa Paradiso. Brian stated he will assist the landscape Committee and the Boar with developing this plan. Landscaping was discussed.

b. Architectural Review Committee - Chuck Dewire reported for Marci Shantz

A MOTION was made by Darrell and seconded by Eileen to approve the Jatropha tree at 4551 Cancello Dr. **Motion passed unanimously.**

- **A.** Cost from Juniper for a vertical cut along Cancello Grande: Brian stated that he will be getting a quote from Juniper on Tuesday.
- **B.** Status of the fountain in the Villa Vivaci pond: Brian received a quote from WET for the fountain repair. The cost to just pull the fountain out is \$475. This does not include the repair of the fountain. Eileen stated that she is in favor of spending the \$475 to have the fountain pulled out to get a quote for the repairs. Darrell stated that we will never know what is wrong with the fountain unless it is checked out. Cheryl reported that Juniper stated that the fountains draw water from the pond and have issues because they intake silt from the pond. Discussion was had regarding the fountain in the pond.
 - **A MOTION** was made by Eileen and seconded by Darrell to approve the proposal from WET to pull the fountain for repairs. **Motion passed unanimously.**
- C. Replacement filters for 4 well pumps: Discussed and approved under Landscape Committee report

Owner stated that the communication between owners and management is poor. She also thanked the Board for helping her out with this issue.
