<u>Minutes</u>: Motion made by Louise and seconded by Brian C. to approve the May 15<sup>th</sup> , 2024 Board meeting minutes with corrections. Motion passed unanimously.

Brian Willams from Twin Palm gave a presentation regarding the driveway plantings and a question-and-answer session.

### **Committee Reports -**

# **Unfinished Business:**

Discussion Regarding Proposal for New Plant Replacement and Irrigation Between Driveways: Madeline presented two proposals from Twin Palms, one for the irrigation between the driveways and the other is for the new planting to be added to the area between the driveways. The irrigation proposal is \$3,964.73 and the planting proposal is \$12,796.25. This includes mulching and removing the debris.

A **MOTION** was made by Brian C. and seconded by to approve \$3,964.73 for the irrigation install and the \$12,796.25 for the new plants in the center of the driveways this will be expensed from the irrigation mapping special assessment, the landscaping and mulch line item and last year's surplus. **Motion passed unanimously.** 

**Palm tree seed trimming quote discussion and vote:** Madeline presented a proposal from Twin Palm in the amount of \$800 to have the seed pods trimmed from the palms on the property.

**A MOTION** was made by Louise and seconded by Marci to approve the palm seed trimming by Twin Palm not to exceed \$800. **Motion passed unanimously.**

<u>Homeowner Input and Comments</u>: Owners made comments from the floor regarding the roof replacement, street lighting and gator signs.
